PREPARATION

Note:

- 1). The pictures are only for reference.
- 2). Two or more persons are required for safe handling of a large monitor to prevent any damages or injuries.
- 3). Avoid touching the screen so as not to cause damage to the screen.
- 4). Accessories may vary depending on the region or model.

Unpacking and Installation

- 1. Open the package.
- 2. Take out the monitor.
- 3. Install the monitor stands.
- 4. Connect the power cord.

Terminal Cover Installation

1. Take out the terminal cover from the top left/right packing material.



41-C/5GU85UUX use top left packing material 4T-C65GU8500X use top right packing material ("TR" / "TL" is written on it)

2. Place the terminal cover on the corresponding position of the rear shell, and promote the terminal cover in the direction of the opposite arrow. The sound of the buckle sounds indicate that it has been installed.

2. Lay down the monitor

①. Place the packing case face up.

②. Put the two side packing materials into the left and right side of the packing case.

③. Please put the top right/left packing material (TR/TL) into the middle position in the packing case. (The putting position as shown in the left image)

3. Installation of Stand Supports

Fix each stand support by fastening two stand screws.

After laying down the monitor, take away the bottom packing material.



NOTE: Please install the stand supports vertically.

4. Installation of Stand Base



- ①. Use Top left/right packing material (TL/TR) as a jig and put it on the floor with the side with the yellow sticker facing up and in the direction of the below illustration.
- ②. Insert Stand Base in the slit of Top left/right packing material (TL/TR). The side with the arrow mark is the back side of Stand Base.
- ③. Fix each Stand Support and Stand Base with three screws provided.

- · After fixing, please shake to confirm whether all the screws are tightened.
- 5. Stand up the monitor
